## SHORT BIOGRAPHY

Short biography: Fouad El Khatib has been promoted General-Engineer in 2022 and currently acts as an advisor on various missions for the French ministry of defense. Previously he was posted as Armament Attaché at the French Embassy in Baghdad (2020-2022), he worked at the General Directorate for International Affairs and Strategy issues (DGRIS) of the French ministry of defense as special adviser of the Director for International and Security Affairs (2019-2020), Deputy-Director of the Directorate for Regional Affairs (2016-2019), after having led the Middle East and North Africa department (2015-2016). He was posted at the French Embassy in Libya from 2012 to 2014. Other previous assignments included positions in the Office of the Prime Minister (SGDSN) as special adviser on WMD counter-proliferation, missile defense and nuclear deterrence, as well as positions in the Directorate for Strategic Affairs of the French Ministry of Defense, as head of the non-proliferation bureau. He also served in the UN Special Commission for the Disarmament of Iraq, in the DGA (French defense procurement agency), in the industry (THALES) and in IISS, a London-based think-tank.
